Exhibitor and Parents understand that no warranty is provided regarding the safety and condition of the show grounds, including trailer parking areas, stalls, warm-up areas, wash racks and competition areas. Accordingly, Exhibitor and Parents agree upon behalf of themselves, their heirs, guardians and legal representatives, not to sue Peppertree Ranch, Noel Sewall, Laura Sewall, Cerro Vista Ranch, Cathy Cerro, or Allan Cerro, or such parties' employees, agents, heirs, successors or assigns or otherwise make a claim against such parties in connection with any injury or death in connection with this horse show.
